GCSC Board Minutes - August 25, 2025

Called to order at 4:35 pm

#### President

o The plan to paint the cement walls at the LaPaz entrance to Taormina is still active.

#### Treasurer

- o Checking and savings accounts: \$111,940
- \$2500 in unpaid fees remain- Leslie will follow up with those in arrears,
- o 2025 taxes have been paid
- The Valerie James arrears is now being referred to the TTCI. Since the property owner is ultimately responsible for fee payment 0as per 1977 CC&Rs and GCSC Policy), and Ms. James is nearly \$1000 in arrears and has not met her negotiated agreement with the GCSC, a letter is being sent to Sherry Fiorentino (#36) who represents the TTCI and TTMH corporations.

#### **Old Business**

#### Garbage area

 A second camera has been installed at the trash area. One shows the interior of the compound, the other is focused on the roadway/entrance. Any board member wishing to monitor the cameras should contact Jon for the QR code and password.

## Streetlights

o Marqui and Leslie will inventory the streetlights not working in September

## Emergency preparedness

- Jon and Kristin have been creating the list of "pod" members and ran an initial test of the network in August. A second test run is planned for late September.
- The GCSC website (<a href="https://www.mnlamberts.com/taorminagcsc.org/">https://www.mnlamberts.com/taorminagcsc.org/</a>) now has information concerning Emergency Preparedness for the Taormina community- found on the site under "Community Information."
- Initial plans have been drawn and presented to the board concerning a new, vehicular emergency escape route from the Taormina community. Moved and seconded: The GCSC agrees to act on behalf of the Taormina community to enter into necessary agreements with neighboring entities and to fund the work required to create a new road exit from Taormina Lane heading west, for use in a declared emergency. Motion passed unanimously.

 Jon and Kristen have developed a Taormina contact list with email and "text accessible" phone numbers. This list will be sent to all board members.

# Housing cleanup

o It was brought to the GCSC board's attention that the City of Ojai had given Terrel Riley (#16) an ultimatum to clean up her house. The LDS Church work group addressed the issue over two days. This action was written up in the City's newsletter publication (Summer 2025).

#### **New Business**

- Board Elections: A self-nomination notice for board members will be distributed within the community and mailed to absent property owners in mid-September. Nominations will be open until October 1<sup>st</sup>.
   Voting will take place in November.
- The board will encourage the former TAPers group to reorganize and plan community activities.
